Right to erasure/ Right to be forgotten*

Following your request, DE KEYZER will erase your personal data without undue delay where one of the following grounds applies:

- Your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed
- You have withdrawn your consent with regards to the processing and there exists no other legal ground for the processing
- You object to the processing and there are no overriding legitimate grounds for the processing or you object to the processing for direct marketing purposes
- Your personal data have been unlawfully processed
- Your personal data have to be erased for compliance with a legal obligation which exists on the part of DE KEYZER
- Your personal data have been collected in relation to the offer of information society services

Right to restriction of processing*

You wish DE KEYZER to limit the processing of your personal data and one of the following grounds applies:

- You contest the accuracy of your personal data. Your personal data will not be processed for the period enabling DE KEYZER to verify the accuracy
- The processing is unlawful and you oppose the erasure of your personal data and request a restriction of the use of your personal data instead
- DE KEYZER no longer needs your personal data for the purposes of the processing but you require them for the establishment, exercise or defence of legal claims

Right to object*

The processing of your personal data (including profiling) occurs (i) for the performance of a task carried out in the public interest (ii) in the exercise of official authority vested in DE KEYZER or (iii) on grounds of the legitimate interests of DE KEYZER or a third party and you wish to object to the processing of your personal data on grounds relating to your particular situation.

Note: DE KEYZER shall no longer process your personal data unless DE KEYZER demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims

You wish to object to the processing of your personal data for direct marketing purposes (including profiling related to such direct marketing). More specifically, you wish that:

DE KEYZER erases all your personal data from its filing systems. DE KEYZER will contact you again in future if access is regained to your personal data from a third party

DE KEYZER does not process your personal data anymore for direct marketing purposes and ensures that you will never receive direct marketing again from DE KEYZER or its partners

III. REACTION OF DE KEYZER TO YOUR REQUEST

DE KEYZER shall provide without undue delay and in any event within one month of receipt of your request, information on action taken on your request.

Depending on the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, DE KEYZER will inform you within one month of receipt of your request.

If DE KEYZER does not take action on your request, DE KEYZER will inform you within one month of receipt of your request and, in addition, DE KEYZER will provide the reasons for not taking action on your request. DE KEYZER will also inform you on the options to (i) lodge a complaint with a supervisory authority or (ii) seek a judicial remedy.

IV. PROOF OF YOUR IDENTITY

If DE KEYZER has reasonable doubts concerning your identity, DE KEYZER may request the provision of additional information necessary to confirm your identity.
